ORDER


CIVIL

This matter was before the Court on telephone pre-trial status conference held on the 11th day of June, 2014, pursuant to regular assignment. All parties were represented by counsel, taking part in the conference. Pursuant to the discussions held and representations made at said conference:

IT IS ORDERED, that:

1. This case is assigned for trial beginning the week of September 15, 2014, with final pre-trial conference to be held on September 15, 2014, at 1:00 P.M. Trial counsel are required to attend the final pre-trial conference in person, unless other arrangements are approved by the Court. All counsel are required to have discussed the case with their respective clients, to have settlement authority at the pre-trial conference, and to have their client or a representative of their client with settlement authority available to reach by telephone at the time of the conference, to discuss settlement alternatives.
2. No written pre-trial order is required. However, all counsel are to file an exhibit and witness list, showing all persons who may be called as witnesses at trial, and all documents or other exhibits which may be offered at trial. This list is to be filed with the Clerk of Court no later than the 15th day of July, 2014, with copies furnished to opposing counsel by that date. Failure to list any exhibit or witness to be used at trial, unless extreme good cause is shown, shall result in exclusion of any unlisted exhibit or the testimony of any unlisted witness at trial.
3. Counsel for Plaintiff is to prepare a settlement proposal, referencing Plaintiff's claims or injuries, further referencing or taking into account any bona fide issues as to liability, and giving brief citations as to quantum, and to send same to opposing counsel no later than the N/A day of N/A, 2014.
4. A deadline for completion of all discovery is fixed for N/A, 2014.
5. A cut off date for filing any exceptions or motions, including motions *in limine* is set for N/A, 2014, and any motions so filed will be set for hearing N/A, 2014.
5. Witnesses should be subpoenaed for the day following the date of the pre-trial conference. Subpoenas are considered issued for the week. Counsel should contact their witnesses following the pretrial conference to advise them of the exact date and time they will need to appear.
