Dear Mr. Scott:

Our firm is legal counsel for the Auctioneers Licensing Board. On September 22, 1998, the Louisiana Auctioneers Licensing Board met at its offices in Baton Rouge, Louisiana. During the course of that meeting, a proper showing was made concerning certain violations by you of the Louisiana Revised Statutes concerning your conduct as a licensed auctioneer. These violations recently occurred at the auction facility known as the St. Maurice Auction. An auction was conducted by an individual who is not a licensed auctioneer in the State of Louisiana. The individual named was Vernon Carter. A review of the roll of the licensed auctioneers in the State does not list Mr. Carter as a licensed auctioneer.

As a result of this information, the Board issued an Order pursuant to La. R.S. 37:3122 directing you to cease and desist from this activity. The order is attached.

The provisions of the La. R.S. 37:3123 prohibit a person without a license from acting as an auctioneer. La. R.S. 37:3121 prohibits, among other things, an auctioneer from aiding and abetting in the evasion of the statutory requirements. A person violating the provisions of the statute by an auctioneer is cause for nonissuance, suspension, revocation, or restriction of your license.

You should be aware that in the event that you do not cease and desist from the above described activity, the Louisiana Revised Statutes authorize the Auctioneers Licensing Board to pursue injunctive relief and the authority to take action concerning your status as a licensed auctioneer.

I appreciate your cooperation in complying this cease and desist order. If you should have any questions concerning this matter, please do not hesitate to contact me.

IT IS ORDERED that Jerome Scott cease and desist from aiding and abetting in the evasion of the provisions of Title 37, Chapter 42 regulating the licensure of qualified auctioneers and auctions house and prohibiting unlicensed individuals from acting as auctioneers and/or conspiring with an unlicensed person with the intent to evade the provisions of Title 37, Chapter 42 of the Louisiana Revised Statutes regulating the licensure of auctioneers. This order specifically relates to the practice of allowing unlicensed auctioneers to conduct auctions at the St. Maurice Auction.
