MEMORANDUM

NOW UNTO COURT comes Plaintiff, Robert Edwin Burns, in proper person, who submits to this Honorable Court this Memorandum in order to substantiate the fact that Defense Counsel drafted a Judgment regarding a hearing for Summary Judgment heard by this Court regarding this Petition on Monday, April 23, 2012. Plaintiff was provided with a copy of Defense Counsel’s proposed Judgment the same day of the hearing, April 23, 2012; however, when Plaintiff notified Defense Counsel the same day, April 23, 2012, via email that he objected to the itemization of the “determinations” that the “court made” in light of the fact the Court stated no oral reasons for its Judgment, Defense Counsel informed Plaintiff via email that “the Judgment has already been submitted. If the Judge doesn’t agree with it, he won’t sign it.” Plaintiff then inquired of Defense Counsel as to whether Local Rule 9.5 was now “out the window.” Upon receiving that email, Defense Counsel informed Plaintiff that he (Brantley) would submit a letter to the Court stating that the parties could not agree upon the Judgment’s wording and that he would resubmit his and Plaintiff could submit a Judgment of his own. Accordingly, Plaintiff has done so with the only deviation from Defense Counsel’s Judgment being the removal of the itemization of “determinations” purportedly made by the Court. Plaintiff’s proposed Judgment is included with this memorandum.
