Synopsis of Probable Cause

Affiant wishes to inform the court that on 07-15-12, at approximately 1124 hrs. Deputy was dispatched to 14350 Peairs Rd. in reference to a battery complaint

Affiant wishes to inform the court that upon arrival, Affiant contacted the Victim Gina Buhler w-f (03-07-67) The Victim stated that her husband the Accused Kenneth Buhler (w-m 10-14-59) committed battery on her by putting his hands on her. He grabbed her arm and pushed her to the floor. The victim stated while she was on the floor the accused kicked her multiple times in the shoulder and in the back. It should be noted that this incident occurred within the parish of East Baton Rouge at the above listed address.

Affiant states that the Accused Kenneth Buhler (w-m 10-14-59) was contacted via public service and agreed to meet this Deputy at the Central Substation. Affiant spoke to the victim, and checked her for visual injuries. The Affiant observed a bruise on the victim's left arm where the accused grabbed her, as well as swelling where the accused struck her.

Affiant wishes to inform the court that that the accused was located at the Central Substation. The accused was advised of his rights which he stated that he understood. The accused admitted to pushing the victim off him to get out of the residence. This Deputy took the accused into custody and handcuffed him
