Dear Ms. Edmonds:

We are in receipt of your response of "no records exist" regarding our FOIA request dated August 15, 2011, which is repeated below:

Any written evidence of the LA State Board of Examiners of Interior Designers having retained security officers of any kind for Board Meetings during the period August 15, 2006 through August 15, 2011. Such evidence should be comprised of, but not be limited to, any written contracts with security officers or their employers, invoices paid for security officers (whether presented for payment by officers or their employers), and checks made payable to security officers or their employers having been cancelled upon payment.

In light of your response, we **expand our request to include hard copies of any imaged checks regarding payments for security personnel held in custody for the Interior Design Board by its bank covering the period August 15, 2006 through August 24, 2011.**

**We also expand our request to include invoices for Interior Design Board legal counsel covering the period January 1, 2011 through July 31, 2011.**

Regarding the request for hard copies of imaged checks, we understand the cost of such service to be \$1 per check that the bank assesses the Board. We agree to pay that charge. Please alert us if that charge is to exceed \$20. Regarding the request for attorney invoices, we will be responsible for any duplication of documents. Therefore, we expect no charge for the review of attorney invoice documents.

If our request is denied in whole or part, we ask that you justify all deletions by reference to specific exemptions of the act.
