Dear DA Stutes:

Please find enclosed a package I mailed to FBI Special Agent Jeffrey Sallet dated August 15, 2016.

As the material makes apparent, the Louisiana Secretary of State's Office has referred the matter to Livingston Parish District Attorney Scott Perrilloux for potential criminal prosecution. As my letter makes clear, I think hell will freeze over before Perrilloux initiates any action against Marvin Henderson or any member of his family when he has the latitude not to. I think that fact is evidenced by Ms. Cotton's open encouragement to provide the material to "another law enforcement office of your choice." I am convinced she encouraged that initiative as a direct result of her dealings with Perrilloux entailing one of his own employees illegally holding herself out as a notary and his indifference to that fact (see highlights in article supplied in FBI package).

I sent the follow-up material to the FBI on the premise that, since the illegal notary attesting to the seller's signatures on the part of Marvin Henderson entails an \$11 million transaction financed by a Federally-insured lending institution, that office may be the appropriate agency to pursue the matter.

It is also my understanding that Attorney General Jeff Landry's Office may have its hands tied in that, from what I understand, about 40 years ago, either Louisiana's Constitution or by way of passage of a statute, caused the AG's Office to largely be one of defending the State in lawsuits and only a "backup" law enforcement agency being able to lead any such investigation only upon referral by a local DA. I certainly do not hold my breath awaiting any such referral by Perrilloux to AG Landry. I also supplied evidence of campaign contributions from JAH Enterprises, Marvin's company, to Perrilloux in the hope that may generate a need for a recusal by Perrilloux.

Failing a recusal by Perrilloux and failing the FBI claiming enforcement of the matter (which may be the case since no loss to a financial institution transpired), I want all

possible avenues of enforcement to be available. With that in mind and going on the premise that a referral may be required by a local DA to AG Landry for enforcement of the action, I provide you with the enclosed package. **The \$11 million transfer entailing the former Evangeline Downs racetrack for which Henderson illegally served as a notary was filed in Lafayette Parish. Hence, that may provide you with any needed authority to refer the matter to AG Landry's office. That is the purpose of this letter to you.**

It is my sincere hope that some law-enforcement agency acts on the matter because, in my opinion, it is just that sort of inaction collectively that garners the feeling of invincibility that emboldens these types of fraudulent acts in the first place.

I appreciate the time you have taken to read this letter and, if appropriate as mandated by Louisiana statute and/or its Constitution, I appreciate you considering referring the matter to AG Jeff Landry for criminal prosecution entailing Mr. Henderson falsely holding himself out as a notary to the public when he has been expressly prohibited from doing so as result of his felony conviction.
